# From the Superintendent-

#### 1. UPDATE-Legislative

Additional Item-Dr. Kell introduced Antoine Blake as the new Buildings and Grounds Supervisor and his wife LaToya.

Four hundred districts participated in a movement to promote the passing of a budget in Illinois. We sent out an e-blast to families asking to contact their representatives.

Dr. Kell shared that she found out that there is a new developer for the Winfield Fuel and Material property who is in the early stages of planning and developing medical offices on that property.

## 2. Approve SASED Board of Control/Governing Board Appointment Resolution

- Dr. Matt Rich will be replacing Dr. Gwynne Kell on the SASED Board and Donna Bartlett will remain the alternate.
- SASED will need to continue renting two classrooms and a sensory room from us next year and the lease will be presented for approval in May. They are aware this is their last year.

## 3. Community Chest Grant

Northwestern-Central DuPage Hospital sponsors a \$100,000 grant and last year Mrs. Dave submitted and was awarded \$4,000 for the SLT/DLP field trips, this year they will receive \$6,000.
